Date:February 05, 2024Re:NEW ASSAY: HPV Primary Screening

In February, as recommended by the American Cancer Society (ACS) and American Society of Colposcopy and Cervical Pathology (ASCCP) guidelines, HPV primary screening will be available in the Molecular Pathology Laboratory at the Hospital of the University of Pennsylvania. Results for HPV high-risk (HR) DNA testing will be immediately available in PennChart (to clinicians and patients). Samples positive or inconclusive for HPV HR DNA will be automatically reflexed to Cytopathology for additional Pap testing which will be reported separately. Methodology and performance characteristics will remain unchanged from the current co-testing and reflex pathways. In addition to the new orderable, some of the other PennChart orderables and test descriptions for Pap and HPV have been updated (refer to table below).

Testing Information:

Turnaround time: 2 business days. Note: for HPV HR DNA positive samples, reflex cytology testing will take an additional 2-10 business days.

PAP01	CO-TEST: PAP + HIGH RISK HPV DNA TEST WITH REFLEX GENOTYPE	Concurrent PAP and HPV HR DNA
PAP02	REFLEX: PAP + HIGH RISK DNA IF ASCUS/LSIL OVER	Reflex High Risk HPV testing when Pap is ASCUS
	25	or LSIL in patient 25 years or older
PAP03	PAP ALONE (NO HPV TESTING)	PAP Only
PAP05	HPV HIGH RISK WITH REFLEX TO PAP CYTOLOGY (HPV PRIMARY SCREENING)	NEW Orderable! HPV Primary Screening
PAP11	ADD ON HPV HIGH RISK	Add HPV after PAP resulted (use when originally misordered or decide now want HPV testing)
PAP12	ADD ON PAP CYTOLOGY	NEW! Add PAP to HPV HR DNA Negative (use when originally misordered or decide now want Pap testing

Ordering: The BOLDED Pennchart orderable below is the order for Primary HPV Screening

Acceptable specimens:

Pap broom/brush/spatula of cervix/endocervix/vagina collected in a ThinPrep® Pap Test collection kit

Unacceptable specimens:

Self-collected cervical swabs, anal swabs
