Positive

Herpes Simplex Virus (HSV) PCR results on patients <30 days of age	Positive
Acid fast bacilli (AFB) (direct smear, culture, secA sequencing, or ID confirmation)	Positive
<i>Burkholderia cepacia</i> (1st isolate on a CF patient)	Positive
